We would like to inform you that, the Board at its meeting held on 29<sup>th</sup> August 2016 has allotted the new set of shares in accordance with the reduction of capital of the Company as approved by the Hon'ble High Court Judicature at Hyderabad in connection with Company above Petition No. 156/2016 to those members whose name appeared as on the record date on 26<sup>th</sup> August 2016 in the register of members.

The Reduction of capital that carried by the company as follows:

1. The company set off the accumulated losses of Rs. 51,638,200/- (Rupees Five Crore Sixteen Lacs Thirty-eight Thousand Two Hundred only) against the paid up capital of the Company of Rs. 54,356,000/- (Rupees five Crore forty three lacs fifty six Thousand Only);
2. On appointed date i.e. 1<sup>st</sup> April, 2015, the Subscribed and Fully Paid-up Share Capital of the Company shall stand reduced from Rs. 54,356,000/- (Rupees five Crore forty three lacs fifty six Thousand Only) divided into 5,435,600 (Fifty four Lacs thirty-five Thousand six hundred) fully paid up Equity Shares of Rs. 10/- (Rupees Ten Only), to Rs. 2,717,800 (Twenty seven Lacs Seventeen Thousand Eight Hundred only) divided into 271,780 (Two Lacs Seventy-one Thousand Eighty) Equity Shares of Rs. 10/- (Ten only) each; and
3. Consequently, every shareholder of the Company, whose name appears on the Register of Members as on the Record Date, received 5 (five) Equity Share of Re.10/- (Rupees Ten each Only) in lieu of every 100 (Hundred) Equity Shares of Rs.10/- (Rupees Ten Only) each, held in the Company;
4. The reconstruction/restructuring of capital shall not cause any shareholder to hold any fractional shares in the Company and in respect of the fractional shares, if any, caused by the reconstruction/restructuring of capital, the same was rounded of to the nearest whole number.
5. After reduction, the capital of the company was of Rs. 2,717,800 (Twenty seven Lacs Seventeen Thousand Eight Hundred only) divided into 271,780 (Two Lacs Seventy-one Thousand Eighty) Equity Shares of Rs. 10/- (Ten only) each.
