SUMMARY OF PROCEEDINGS OF THE EXTRAORDINARY GENERAL MEETING OF NUTRICIRCLE LIMITED

The **Extraordinary General Meeting ("EOGM")** of the Members of **Nutricircle Limited**(the "Company") was held on **Wednesday, September 25, 2024 at 11:00 a.m.** at the registered office of the company. **The said EOGM commenced at 11:00 A.M (IST) and concluded at 1.10 P.M (IST).**

Mr. Hitesh Mohanlal Patel Managing Director of the Company chaired the Meeting and welcomed the Members of the Company.

With the requisite quorum being present, the Chairman called the meeting to order and welcomed the Shareholders to the Company's EGM. The Chairman informed that the Company had provided its Members the facility to cast their vote electronically through the **Bigshare Services Private Limited ("RTA") SEBI Registered Category-1)** before the Meeting. The Chairman also informed that the EGM Notice had been sent electronically to those members whose email ids were registered with the Company/RTA or Depository Participants.

The Managing Director informed that the facility for remote e-voting commenced at 9:00 A.M. (IST) on Sunday 22ndSeptember, 2024 and concluded at 5:00 P.M. on Tuesday, 24thSeptember, 2024. He also informed that voting by electronic means was also available during the EGM to those shareholders who had not already voted by means of remote e-voting. He also stated that as the EGM is being held physically, the facility of appointing proxy was applicable. He further informed the Shareholders that M/s. Amarendra Mohapatra & Associates, Practicing Company Secretary was appointed as the scrutinizer to scrutinize the voting through electronic means (i.e. remote e-voting and voting at the meeting by using electronic system) in a fair and transparent manner.

Thereafter, the Notice convening the EGM of the Company was taken as read by the Chairman, with the consent of the Members present.

The Chairman then announced that the e-voting facility was open and Members may visit the voting page of **BIGSHARE i-Vote website** thee-voting website and cast their vote.
