1. The brief particulars of the scheme of reduction in capital are as mentioned below:  
The scheme of reduction of capital of the Company was approved by the Hon'ble High Court of Hyderabad vide order dated 14/06/2016, Pursuant to the Scheme of Arrangement for Reduction of Share Capital as approved by the Hon'ble High Court of Hyderabad: The paid up capital of the company shall be reduced from Rs. 5,43,56,000/- divided into 54,35,600 equity shares of Rs.10/- each fully paid-up to Rs. 27,17,800/- divided into 2,71,780 equity shares of Rs.10/-each.
2. As per Exchange Notice No. 20160824-6 dated 24 Aug 2016 the company had fixed August 26, 2016 as record date for giving effect to the reduction of share capital.
3. Trading members of the Exchange may also note that in respect of shares held in Physical form, the company has issued new certificates. Further, company had




issued public notice dated 3<sup>rd</sup> September, 2016 requesting shareholders to surrender the old certificates with the Company for endorsement.
